TEACHING EXPERIENCE

Graduate courses

- New Venture Management (MGT 5315, Texas State University): This course provides an overview of the entrepreneurial process from the initial idea through start-up, growth, and harvest. Students learn how to write a business plan, manage all the elements of an entrepreneurial business, and develop a better understanding of the entrepreneurial life path.
- Administrative Strategy (MGMT 5190, University of North Texas): Capstone course providing the integration of functional areas of business. Requires students to determine policy at the general- or top-management level. Students address strategic organizational problems and the optimization of the total enterprise. Course includes the use of lectures, case analyses, and special topics. This course must be taken in the student's last semester of course work.
- Managing Organizational Design and Change (MGMT 5120, University of North Texas):

 Examination of the development of organizational competencies and capabilities through the study of theory and tools related to organizational design and change. Emphasis is placed on

the use of horizontal and vertical linkage mechanisms that provide the organization with the flexibility to adapt to a rapidly changing competitive environment. Definition of management roles are emphasized in the change management process.

- Seminar in Business Ethics & Social Responsibility (MGMT 5710, University of North Texas):

 Examines the strategic purposes of the firm both as an economic and social entity within the global marketplace. Topics include: ethics in business and ethical decision making, corporate social responsibility and corporate citizenship, and stakeholder management, including shareholders, employees, customers, the community, government, and the environment.
- Organizational Behavior and Analysis (MGMT 5140, University of North Texas): Research emphasis in organizational behavior stressing organization-people linkages and relationships, including selection, orientation and training; job design and reward systems; supervision; formal participation schemes; appraisals and development; organizational structure and design; communications, control and conflict resolution. Examination of behavioral science methodologies and strategies. Applications to areas of organization theory, development, planning, and implications for management and employee relations.

Undergraduate courses

- Business Policy/Strategic Management Capstone (MGT 4335, Texas State University; BUS 4853, Mississippi State University; MGMT 4940, University of North Texas): An integrative course in strategic management and business policy that utilizes the case method of instruction. A capstone course involving the analysis of business through the application of principles of accounting, communications, economics, finance, management, marketing, quantitative methods, and related disciplines.
- Studies in Entrepreneurship (MGT 3360, Texas State University): Students gain personal insights into entrepreneurship as entrepreneurs describe their contributions, reveal the sources of ideas, and discover ways of growth and success. Includes starting and managing businesses as well as ownership forms, sources of funds, location analysis, facility requirements, management, marketing, and feasibility plans.
- Entrepreneurship (MGT 3323, Mississippi State University): An introduction to the processes involved in owning and managing a business. Includes the entrepreneurial activities normally associated with starting and operating a business.
- Business Creativity and Innovation (MGT 4390K, Texas State University): Focuses on the importance of creativity and innovation to business organizations. Topics include the generation of creative ideas, transformation of ideas into commercially viable products/services, legal protection of new products/services, and environmental factors contributing to innovation success. Course objectives are met primarily through classroom discussion and exercises.
- <u>Management Concepts (MGMT 3820, University of North Texas)</u>: An introduction to management theory, various management functions, and managerial interaction with internal

and external environments. Students are introduced to several important topics such as corporate social responsibility, ethical issues, and global management. Emphasis is given to managing change, innovation, and diversity in the organization.

<u>Human Resource Management (MGMT 3860, University of North Texas)</u>: An introduction to human resources (prior term—personnel) management. Topics include employment, placement and H.R. planning, training and development; compensation and benefits; health, safety and security; and employee and labor relations.

Organizational Behavior (MGMT 3720, University of North Texas): Individual behavior in formal organizations. Cases, lectures, and experiential exercises in organizational culture, motivation, leadership, dynamics of power, perception and attribution, communication, decision making and performance, and individual differences.

International Management (MGMT 4660, University of North Texas): A comprehensive framework is used to study the management of multinational operations in cross-cultural environments with a focus on the decisions that managers must make. Topics include strategic planning, organization, human resources, operations management, entrepreneurship, and ethics.
